

#### KNOW ALL MEN BY THESE PRESENTS:

That we, all of legal age and residents of the Philippines have this day voluntarily associated ourselves together for the purpose of forming a non-stock, non-profit mutual benefit association under the laws of the Republic of the Philippines.

First - That the name of the corporation shall be KNIGHTS OF COLUMBUS FRATERNAL ASSOCIATION OF THE PHILIPPINES, INC.

Second - That the purposes of the corporation are:

- To render mutual aid and assistance to members and their immediate families and their beneficiaries for losses and damages arising from injuries and/ or losses of lives and properties. (As amended on July 16, 2004).
- To render mutual aid and assistance to sick, disabled and needy members and/or immediate members of the families. (As amended on July 16, 2004).
- c) To engage in public and private relief works and to provide for the economic, social religious and educational requirements and needs of the members and their families:
- d) In general, do such acts and things and to undertake such activities not otherwise prohibited by law which are calculated to help the members and their families in particular and the country in general or which may be necessary directly or indirectly for the accomplishment of the purposes for which the corporation has been formed or organized.

Third - That the place of the principal office of the corporation shall be located at Knights of Columbus Fraternal Association of the Philippines, Inc. (KCFAPI) Center, Gen. Luna corner Sta. Potenciana Streets., Intramuros, City of Manila, Philippines. Branch offices may be established elsewhere whenever necessary and expedient. (As amended on September 9, 2014)

Fourth - That the term for which the corporation is to exist is fifty (50) years from and after the date of incorporation: and is hereby extended for another period of fifty (50) years from and after the expiry date of the said original term on August 1, 2008, (As amended on July 16, 2004).

The Trustees of the Association shall serve as Fraternalisty and shall not receive any compensation or remuneration for their services. (As amended on September 9, 2014)

Seventh - That Dr. Ramon F. Campos has been elected by the incorporators as Treasurer of the corporation who shall act as such until his successor has been duly elected and qualified in accordance with the By-laws and that as such Treasurer, his has been authorized to receive for the corporation and to receipt in its name for all, fees, dues, assessments, funds and property that shall accrue or to be acquired by the corporation thru contribution, gift, donation or otherwise.

Eighth – That the corporations shall have no shares of stock, only Founder Members shall be entitled to vote in the election of the members of the Board of Trustees and at any and all corporate purposes whatsoever to the exclusion of the other members of the corporation. The following shall be the Founder or voting Members of the Association:

- All members in good standing of the Knights of Columbia in the Philippines Ommil
  who have contributed the sum of P 500.00 not later that December 31, 1961 under such terms if the property and conditions as may be decided by the Board of Trustees.
- Councils of the Knights of Columbus in the Philippines to be represented by the Grand Knights thereof upon payment of the membership fee of P 500.00 under such terms and conditions as may be decided by the Board of Trustees
- Members of the Catholic Hierarchy of the Philippines may become Founder members without the payment of P 500.00 upon their formal acceptance as such founder members as may be offered to them by the Board of Trustees.

The following shall be the regular or non-voting members of the Association:

Those who subscribe to one or more benefit certificates under any of the benefit plans operated by the Association and who are not founder members.

Ninth - No part of the income which the Association may obtain as an incident to its operation shall inure to the benefit of any private individual. Any profit obtained by the association as a result of its operation, whenever necessary or proper, shall be used for the furtherance of the purposed enumerated in Article II, subject to the provision of Title XI of the corporation code of the Philippines. (As amended on September 9, 2014)

Tenth- In the event of dissolution, the existing assets of KCFAPI will be passed on to KC Philippines Foundation, Inc., and Knights of Columbus Fr. George J. Willmann Charities, Inc. (As amended on September 9, 2014)

<u>Eleventh</u>— Upon the initiative of the Board of Trustees by a majority vote thereof proposed amendments may be considered adopted upon the approval of 2/3 of the members entitled to vote either in a special or during the annual meeting or upon authorization given to the Board to adopt said proposed amendments by letter resolution or otherwise from 2/3 of the Founder Members without the necessity of calling for a special meeting.
